# About Farmington Area Public Schools

- ➤ ISD 192 includes all of the City of Farmington, a portion of Lakeville, and five surrounding townships; total district population exceeds 36,000
- Student population is about 7,000 and expected to be stable the next 5 years
- > 5 elementary schools, 2 middle schools, 1 high school
- Largest employer in Farmington employs 900 staff with about 490 licensed teachers
- Strategic framework drives district purpose, goals, and decision-making
- Profile of a lifelong learner includes 3 objectives that are central to our work



## ISD 192 Board of Education

#### The School Board is comprised of:

- Six directors and one ex-officio non-voting member, the Superintendent
- Terms are 4 years, with 3 seats on the ballot during the November General Election in even years
- ➤ All Farmington School Board members are "at-large" and represent the entire community
- A successful school board must function as a team with clear strategies and goals (each member is 1 of a Board team of 6 members)



# **Board Meetings**

#### Business Meetings and Workshops (2 to 4 hours per meeting):

Generally, the board holds one business meeting and one workshop each month (with some exceptions due to holidays or state statute)

#### Committee Meetings (1 to 2 hrs per meeting):

Each member serves on at least one, but usually two committees that meet as arranged

#### **Outside Organizations:**

Directors may also be appointed to represent the board with other district or professional organizations with their own meeting times and cadences



# **Board Member Training and Commitment**

- Complete board-required training (orientation, mentor, and whole board training)
- Complete MN State-mandated training (MSBA I & II) within 6 months of being sworn in
- > Prepare for board meetings, be present and on time
- Model effective leadership and comply with all statutes and policies
- > Serve on at least one board committee
- > Attend board events
- > Attend district and community events



## What is a School Board?

A body of locally elected individuals who represent the communities they serve.

- Power and authority are granted to school boards by the state.
- The board only has authority when acting as a whole. Individual board members have no authority in and of themselves.
- Purpose is to ensure effective, efficient, and equitable delivery of high-quality education to all the school district's students through adoption of policy.



## Fundamental Role: To Govern

- > School boards are most effective when focused on "the big picture"
- Core responsibilities:



**Policy**: Ensure the right policies are in place, are current and consistent with the law, and are followed consistently



**Budget**: Ensure schools are adequately funded and that financial resources are appropriated and used responsibly



**Superintendent**: Hire, direct, and evaluate the performance of the superintendent who manages the day-to-day operations of the district

# Governance Responsibilities

#### School board members work to:

- Develop a vision and establish priorities for the district
- Set goals and align resources to those goals
- Monitor outcomes and progress, most notably for student achievement
- Set school district policy
- Approve and oversee the budget, levy taxes as allowed
- Approve collectively-bargained employee contracts
- Advocate district and student needs to lawmakers
- Evaluate the superintendent (CEO) of the district
- Communicate and collaborate with public



## Limitations

#### School boards do not:

- Make personnel decisions, other than about the superintendent
- Make management or operational decisions, other than through the established policy-making process



## Individual school board members **do not**:

- Speak for the board or on behalf of the district, except to share on matters that have already been approved by the board
- Direct work of district staff, other than the superintendent by board action

# Administration Role: To Manage

# Administration has the authority of day-to-day management with responsibilities for:

- Resource management: financial, human, and physical
- Instructional leadership
- Performance management and professional development
- Continuous improvement
- Procedures and practices aligned with district policy
- Staff, parent and community relations



# Code of Ethics and Standards for School Board Leadership

- Expectations are outlined in <u>Policy 209 School Board</u> <u>Code of Ethics</u>
- The MN School Boards Association (MSBA) has five Standards for School Board Leadership:
  - Conduct and Ethics
  - Vision
  - Structure
  - Accountability
  - Advocacy and Communication



# What Qualities Make a Good Board Member?

- Passionate about learner-centered culture, achievement, and aspirations
- Motivated by the best interests of each learner
- Able (and willing) to make difficult decisions and focus on problem-solving
- An effective communicator who is willing to listen
- Willing and able to spend time and energy on school board business
- Committed to governance and respecting the school district's chain of command
- Collaborative and able to function as a member of a team
- Willing to support the decision of the board publicly and privately



## How to Become a Candidate

- File an "Affidavit of Candidacy" at Farmington High School
  - Filing period is August 2-16, 2022
  - District office is open 7:30 am to 3:00 pm Monday through Thursday, and Tuesday, August 16<sup>th</sup> from 7:30 a.m.-5:00 p.m.
  - > Filing fee is \$2.00
- You will receive a packet of information regarding campaign regulations and other documents to help you connect with voters
- General election will be held Tuesday, November 8, 2022
- Terms begin January 2, 2023

# Eligibility Requirements

- At least 21 years old
- Eligible voter
- > Resident of the school district for at least 30 days prior to election
- Must not be a convicted felon whose civil rights have not been restored
- > Must not earn more than \$20,000 per fiscal year as a district employee

# Campaign Financing

- Read through the Secretary of State's Campaign Finance Manual
- ➢ If you receive or spend more than \$750, you must file your finance report within 14 days
- Additional reports are due 10 days before the election
- All candidates must file a final financial report within 30 days of Election Day
