FHS students who complete their Math, English or Science coursework in Trimester 2 will take the MCA assessment for that content in the last full instructional week of Trimester 2. Otherwise, eligible FHS students will take the assessments in their class Trimester 3.

- 3/4/19 - 5/10/19: **MCA** Science
